 Re: Zone II Shows in 2009 and 2010

Linda, the Zone II Coordinating Committee met in Las Vegas, Nevada on Sunday, November 23rd to vote on the Zone II show location for 2009. All four states in our zone were represented in the meeting.

The Zone II Coordinating Committee agreed (unanimously) to hold the 2009 show in Salt Lake City, Utah, where it's been held the past 4 years. The date of the show will remain unchanged, and will be held on the Memorial Day weekend. During this meeting, locations and dates for the 2010 show were also held. The information from the two competing bids was not easily comparable, and the board desired to give the California bid additional time to create comparable financial data. The board tabled the vote for 2010 until the next meeting.

At the November meeting, the board voted on new officers for the upcoming year as follows:

- President – Todd Goodwin, Nevada
- Vice President – Tony Lucas, California
- Treasurer – James Christopherson, Utah
- Secretary – Chuck Marx, Arizona

During this meeting, the Board also agreed to hold its next meeting on January 25th in Las Vegas, Nevada to vote on the location for the 2010 show.

The Zone II Coordinating Committee met on January 25th, 2009 and agreed to unanimously agreed to hold the Zone II show for 2010 in Utah. The Board did not select a date for this show, as the Board expressed a desire for the host club to avoid holding the Zone II show on top of a date already reserved for an APHA POR within the Zone. We will discuss the show date at our next meeting.

Financial results for the year were discussed and the Zone II results are still strong. A financial report will be forthcoming, but Zone II started the year with a positive cash balance and hosted a profitable show in 2008 – again one of the Top 10 shows in the country.
