

**Minutes of Zone 2 Meeting held May 27, 2007 at the 2007 Western Regional Zone 2 Show, South Jordan, Utah.** Present were Bob Lentz CA, Tony Lucas, CA, Katy Lentz (Alt-CA), Terri Wirthlin (NV), Sharon Avery (NV), Todd Goodwin (NV), James Christopherson,(UT), Marla Fadel, (UT), Lynn Harding (UT), Brad Jones (Alt-UT), and, Chuck Marx, Kerry Aycock and Tom Gilmore from Arizona. Meeting was called to order at approximately 7:30 p.m. by President Sharon Avery.

**Minutes of last meeting held 2/25/2007 in Las Vegas, NV**

There were no corrections. James motioned to approve the minutes as submitted, seconded by Todd. Minutes approved.

**Treasury Report**

There was no formal treasury report. Show Financial will be presented at the next meeting.

**2007 Show**

As the 2007 show has just concluded there are no official results. Entries were approximately 1300, up slightly from 2006. James thanked everyone for their hard work and long hours. Everyone contributed to making the show a success. Discussion on what worked and what needs improving. Not having the holding area this year worked well. Tony & Bob did a great job on the gates getting exhibitors in and out of the arena. Bob suggested having a “no spray zone” when watering the arena. Suggestion to have patterns timed and go back to making pattern books rather than individual patterns, even though the cost is a little higher. Trail warm up with Don Lehman went well, income to be split 60/40 with Zone 2/UPHC. No complaints regarding judges. Laura Fowler, head ring steward did a great job, agreed to come back next year but she needs to know the schedule as soon as possible.

Suggested change for halter: Amateur & Youth Mares, then Geldings, followed by Open Mares, Geldings, Stallions. Discussion on exhibitors lining up for placings. Classes can load while previous class is being placed. There was a problem with trainers talking to exhibitors while the class was still being judged, James spoke to the trainers involved.

**Presentation of 2008 Zone Show Bid proposals**

The Utah Paint Horse Club and the Northern California Paint Horse Club were the only clubs submitting bids. Tony presented the Northern California PHC bid and James presented the Utah PHC bid. (Both bids are attached.) There was discussion on the bids. California representatives again expressed the CCC’s desire for the Northern California bid to be accepted based on the original 3 year rotation agreement. Others felt the California bid was not acceptable based on date, financial strength and costs, and the success of the show since it’s move to Utah. After discussion, Sharon called for a vote on the 2 bids. Results: 3 votes for the Northern California PHC bid and 5 votes for the Utah PHC bid. 2008 Zone Show to remain in Utah. Bids will be considered annually for the 2009 and subsequent Zone 2 shows from all the clubs in the Zone.

Sharon suggested James be retained as the Show Manager for the 2008 show so he can begin contacting and hiring judges. Motion by Todd to hire James for 2008 show manager. Marla seconded, passed.

Next meeting will be July 25, 2007 in Las Vegas.

Motion to adjourn by Terri, seconded. Meeting adjourned 9:15 p.m.
